A competition size ring of 30 x 60 feet will be set up. You are free to use treats or toys in the ring if you wish. Our competition music system will be set up and manned.

Everyone will have the opportunity to use the ring for two separate five minute sessions (which can be combined if desired). What a great way to get your dog used to our new Freestyle venue with a built-in crowd and distractions. With the two separate times in the ring you will be able to go back in the second time to fix up mistakes made the first time.

This will also be a good opportunity for everyone to meet at one place on the same day to cheer each other on. We have some new people just starting out, so this will be a wonderful opportunity for them to get to know everyone. It will also be a chance for Ray's two classes to get to see each other to share training tips and ideas. Hopefully some of our members from the Island and Washington State will be able to join us.
